# A Note To Readers

*Dear Reader,*

I am glad to share with you Pacta's journey over the past two years in this report. With the pandemic showing signs of receding, we came together as a team to work physically from our Bengaluru office in mid-2022. Until then, Pacta was a fully remote operation.

I set up Pacta in 2016 to provide legal services to non-profit clients, since I noticed a dearth of affordable, high quality legal services tailored for the social sector. From being a two-member team with two clients in 2016, Pacta has come a long way in the last seven years. We are now an all-women team of 12 lawyers and public policy specialists.

In the past two years, Pacta has enhanced the scope of work, from a social sector exclusive law firm to a think-tank. As a think-tank Pacta pursues research to enable evidence-based public policy across five thematic areas - education, philanthropy, disability, technology and gender.

Our contribution to India's public policy dialogues became richer, since I had the opportunity to spend 10 invigorating months at Princeton University's School of Public and International Affairs, where I pursued a Masters in Public Policy. I was in Princeton from July 2021- May 2022, among eminent faculty and accomplished peers. This gave me the opportunity to view India's policy conundrums from a distance, and through diverse lenses. The Princeton experience equipped and empowered me with the skills to lead and direct rigorous research in public policy at Pacta. I returned with renewed public service commitment.

Though we had kept going through the pandemic, operating across time zones, Covid-19 infections among the Pacta team and close family brought us many anxious moments. We were immensely lucky to tide over the trying times. Pacta had the opportunity to support several of India's civil society responses to the pandemic, such as Breathe India and Covid-19 Vaccination Drives by drafting funding agreements and MOUs on behalf of our clients.

Despite its challenges, we used the pandemic as an inflection point for several research studies. In August 2020- January 2021, we piloted an exploratory study on impact of the Covid-19 pandemic on inclusive education for children with disability. Between June- December 2021, we researched the Impact of the Pandemic and Technology Transitions on the Future of Work in South Asia. The year 2022 was very significant for us, because we won the first Multilateral research grant we applied for. The United Nations Women selected Pacta to undertake an Exploratory Study on the Impact of Three Gender Equality Laws Applicable to the Corporate Sector in India. The experience was an exhilarating one.







# 04

## Our Projects

### *Pacta Law*

---

1. Pacta has advised on setting-up and structuring and governance of 10+ non-for-profit entities. We help social sector founders navigate the question of which would be the most appropriate entity to set up.
2. In the last two years we have drafted variety of contracts and collaborations on behalf of
  - Partnerships and Memorandum of Understanding as part of civil society's Covid-19 responses. This included mobilising medical aid and relief including oxygen and oxygen concentrators, supply of PPE kits, masks and sanitisers and Covid-19 vaccination drives.
  - Helped set up tele-medicine platforms and services in government hospitals, enabled last-mile health infrastructure through tele-medicine and migrated menstrual and reproductive health programs online
  - Engineering contracts to build schools and universities across India
  - Contracts that envisaged skilling of labour who had lost jobs due to work-from-home mandates on new models of work and emerging technologies
  - Initiatives for implementing good practices relating to mental health at the workplace
3. We supported our clients to adopt the work-from-home mandates while supplying them with amended policies on sexual harassment at the workplace, enable legally and ethically compliant systems to ensure child-safety as education migrated on-line and modify employment, leave and work-from-home policies to suit the need of the times.
4. We drafted 50+ grant agreements to support research grants and program grants to not-for-profit organisations that accommodated the uncertainties associated with working during the Covid-19 pandemic.

5. Several laws were amended in the last two years and we have advised on:

- The new labour codes and its applicability to non-profit entities
- Import related compliances for COVID relief programs
- Implications of amendments to the Foreign Contribution Regulation Act (FCRA Amendment Act, 2020), Corporate Social Responsibility (CSR) laws (Companies (CSR Policy) Amendment Rules, 2021, 2022) and data privacy laws (the Information Technology Rules, 2021) for the Indian Social Sector

## *Pacta Policy*

Pacta pursues research to enable evidence-based public policy across five thematic areas - education, philanthropy, disability, technology and gender. Our research is sometimes commissioned and many-a-time self-directed. This allows us to choose our research questions and carry out independent, non-partisan work. We have a heavy focus on the disability sector. Our commitment to research in disability comes from acknowledging gaps in translation from policy to law to practice, and towards enabling meaningful inclusion of people with disability.

### *Policy Research Studies by Pacta*

#### Forthcoming

1. *Gender (2022) Exploratory Study to Assess the Implementation of Three Laws on Promoting Gender Equality in the Corporate Sector in India* (commissioned by the United Nations Women, India)

Pacta's exploratory research, under the aegis of UN Women, the European Union and We-EmpowerAsia studied the representation of women on boards of Indian listed companies. The study aimed to assess the state of gender diversity on corporate boards, examining the involvement of women directors in corporate decision-making. It was found that in 2020-21, men occupied 81.89% (2020-21) of the board positions. Further, it was found that corporations meet the minimum compliance requirement. On the positive side, it established that law has been effective in initiating gender sensitive conversations on corporate boards and enabled active participation of female board members.

## In Progress

1. *'Understanding the Intersectionality of Tuberculosis and Disability in India'*  
(Commissioned by Reach India under the aegis of United States Agency for International Development)



Tuberculosis (TB) is one of the leading causes of mortality and morbidity in India. While the TB elimination program is one of the best of its kind, run with robustness and efficiency, there is still a gap in the understanding of the long-term effects of TB i.e., in causing disabilities and how persons with disabilities are affected by TB. Through this study, we will help strengthen the vision of the National Strategic Plan for Elimination of Tuberculosis (2017-2025) by providing recommendations on the need for a more inclusive and equitable approach to disability in the care cascade. Early findings have pointed out that people with disabilities are missing from and/or invisible to India's public health systems.

## 2. *'Data Gaps in Disability Data in India' (Independent Research)*

Pacta is conducting a study that aims to highlight the existing gaps in disability data. The project acknowledges the importance of data on persons with disabilities in enabling improved research and policy implementation. Through the project, we highlight some critical missing data from the existing data sources and provide actionable recommendations to overcome the same. The data gaps are looked upon by broad themes: Socio-economic indicators, Health, Education, Employment and Social Protection, Access to Policies and Institutions etc.

## 3. *'Survey on 'Obtaining Universal Disability Identity Card: Caregivers' Perspectives on Challenges' (Independent Research)*

Inclusive policies for people with disability are missing in India because of lack of relevant data pertaining to people with disabilities. The government's Universal Disability Identity Card (UDID) is equivalent to Aadhaar for people with disabilities. But getting the UDID is a nightmare. There are several obstacles to obtaining UDID in India. In collaboration with Nayi-Disha, Pacta has developed a survey instrument in English, Hindi, Kannada and Telugu that will help to identify the barriers to obtaining the UDID.

## 4. *'Explaining Low Corporate Social Responsibility Funding for Promotion of Sports in India' (Independent Research)*

This study aims to identify why CSR to promote sports is less than 2% of the total CSR spend. Compared to other categories under Schedule VII of the Companies Act 2013, such as education and health, sports receives a very small percentage of funding. This study will identify challenges in fundraising by sports non-profits in India, determine factors that feature in the calculus of sports funders, provide inputs on fundraising strategies for sports non-profits, and catalyze policy solutions to enable better funding for sports.

## 5. *'Competition Law and Abuse of Data Dominance in Food Delivery Platforms' (Independent Research)*

The emergence of data as a significant commodity in the digital world has come with a host of regulatory issues. In this context, our project looks at data dominance in digital platforms, with a focus on food aggregators such as Swiggy and Zomato. In this study, we look at how early entrants and big companies accumulate data, and how this becomes an entry barrier for other firms to enter the same market. Through a comprehensive review of literature on the topic, jurisprudence, primary data, and interviews with stakeholders, we make a case on why data related practices must be regulated under competition law within the Indian legal framework.

## Completed

6. (2022) Conference Paper Presentation Titled **‘Legislative and Policy Measures for Inclusion of Children with Disabilities in Early Childhood Education’** (in collaboration with Vidhi Center for Legal Policy; Presented to GNLU Right to Education Conclave)

The Nation Education Policy envisaged early childhood care and education from age 3 onwards. But the Right To Education Act provides every child between ages 6-14 the right to education. There is a need to evaluate the policies and laws to understand how inclusion for children with disabilities at the early childhood (ECE) level can be assured in the future. Using a 4A framework, Pacta assessed the various education policies, laws, and schemes for inclusion at the ECE level. Our findings revealed that the current legal policy frameworks do account for different factors such as physical accessibility, curricular accommodations, teacher training, and the creation of accountable environments for inclusion of children with disabilities. However, they remain prescriptive rather than practically enforced. Hence there is a need for developing an actionable legal framework for children with disabilities at the ECE level.

7. (2021-22) Research Report Titled **‘Future of Work, Digital Futures in Asia Series’** (commissioned by ITforChange in special consultative status with the United Nations ECOSOC)

Touted as the ‘Fourth Industrial Revolution’, or 4IR, the near future is characterized by the ‘Internet of Things’ (IoT), Artificial Intelligence (AI), augmented reality, and advanced manufacturing technologies such as 3-D printing. This paper captures some of the trends which are beginning to take shape and are expected to substantially transform the near future of work. This includes the growing prevalence of artificial intelligence and digitalization across employment, education and reskilling, and businesses in key economies in South Asia, Southeast Asia and East Asia (South Korea, Japan, China). The paper also discusses the policy measures that are essential to make 4IR equitable and inclusive.

8. (2021) Research Report Titled **‘Corporate Social Responsibility and Sexual and Gender Minorities: Building the Bridge’** A Study of the Status of CSR in India for LGBTQ+ Initiatives and a roundtable discussion with significant domain stakeholders (commissioned by Solidarity Foundation)

Less than 2% of CSR funds in India have been spent on Sexual and Gender Minorities. Pacta’s research helped to establish explanations for the poorly financed LGBTQIA sector. Pacta studied international and Indian legal positions on- Recognition of ‘Third Gender’ and Decriminalization of Consensual Same-Sex Relationships. Despite progressive judg-


ments, essential civil rights remain elusive for sexual and gender minorities. It was found that Corporate actors can lend support to the LGBTQIA+ sector by: (1) Supporting organisations engaged in SGM welfare through direct CSR contributions; (2) Differentiated measurement & reporting of CSR impact on SGM community/individuals; (3) Supporting research and empirical studies to identify the needs of the community, and (4) Supporting change in social perception and improving social inclusion through self-driven initiatives.


9. (2021) *Exploratory Study-Impact of COVID-19 on the Status of Inclusive Education Opportunities in India* (Funded by Azim Premji University)

As education in India and across the world shifted online in 2020 with the onset of the COVID-19 pandemic, it was accompanied by a rise of EdTech and e-learning platforms. This also brought into sharp focus the impact of unequal access to education and the growing digital divide. Pacta, in collaboration with Dr Kirthika Rajaraman and through the funding support of Azim Premji University, carried out a research to study the impact of COVID-19 on inclusive education for children (aged 6-14) with Neurodevelopmental disabilities (NDD) in the state of Karnataka. The study concluded that there is a looming threat to inclusive education practices and their manifestation in the post-pandemic school. A combination of short-and long-term strategies to drive and improve the participation of children with disabilities in the education system is the need of the hour.

## *UPCOMING PROJECTS - PROTEST DATA IN INDIA*

---

The Pacta team constantly looks for new opportunities for research that is shaped and informed by events on the ground. We came across the Armed Conflict Location and Event Dataset (ACLED) Project, that provided fortnightly updates on protests taking place in several countries including India. **India has the highest number of protests in the world from 2016-2021, as per data from ACLED. India sees about 13000 protests per year and 36 protests per day.**

We dived into the data a bit and were intrigued by patterns that emerged in India. We are now considering commencing a new Situation Report (SitRep) series that will carry India Protests pertaining to Labour, Environment and Urban Amenities. The SitRep will carry updates on protests on these subject matters from across India, and will be based on the ACLED Database. The ACLED database itself is based on news-reports compiled from periodicals, dailies and other e-sources. The database also records events reported by local partners, that is, organizations with information on local events that have partnered with ACLED.



## Future Kaleidoscope

### **Hybrid setup increasing in popularity**

Modern social initiatives are beginning to assume sustainable structures, as they include their own revenue streams to fund their charity operations. Working with nonprofits, we have seen how the same services are often rendered to clients for-profit as well as not-for-profit. We expect this trend to strengthen and continue in the coming year.

### **Indian philanthropies - creating enabling environments**

Philanthropic giving in India has become conscious about creating impact, while also nudging non-profits towards financial sustainability. Donors are also focussed on building capacity for fundraising and enabling measurable impact. We are seeing grant agreements adopt more equitable language and models of funding. We are seeing a gradual shift in openness towards unrestricted grants (think McKinsey Scott type large unrestricted grants) and expect more philanthropies to make unrestricted grants in the coming year.

### **Data is the New Gold**

Yes, we all know that this is true in the private for-profit sector. But even civil society is becoming more and more intertwined with data and therefore data governance. More people in civil society have begun to speak about the digital commons, digital public infrastructure, data for good and digital rights. As ChatGPT threatens to replace google search, we must all be concerned about how digital systems must be designed and regulated. We foresee a lot of legislative and regulatory action on digital systems - markets, ed-tech & gaming, health in the coming year.

The Pacta team is looking to pick new challenges to work on in the coming year. We invite you to reach out to us for collaborations and collective action. After all, as someone recently pointed out, *“if power had a shape, it would be a circle, not a triangle”*.
